You shall not be obliged to accept any application for the Bank Guarantee requiring a format or text under which the amount payable or the circumstances in which payment is to be made is unclear or otherwise open to dispute. In the event of no format or text being attached, it shall be left to your absolute discretion to determine the format or text of the Bank Guarantee, which will incorporate the principal conditions as stated above.

We shall pay you the guarantee commission, which is non-refundable for the entire guarantee period including the entire claim period relating to the Bank Guarantee. For the purpose of this provision, "claim period" means the period beginning on the expiry date of the guarantee period relating to the Bank Guarantee and ending on the day on which, pursuant to all relevant laws, no claim may be made by any person under the Bank Guarantee. For the avoidance of doubt, the claim period is the period, which the beneficiary is entitled to make a claim under the Bank Guarantee. No new liability can arise under the Bank Guarantee after the guarantee period.

The guarantee commission shall be payable in advance for the entire guarantee period, upon the issuance, renewal or extension of the Bank Guarantee (as the case may be).

We hereby authorise you, if you think fit, without reference to us, to debit our account to the extent of all such sum or sums of monies which you may be liable under the Bank Guarantee whether before or after the beneficiary of the Bank Guarantee has made a claim on you for payment.
