Any transaction concluded by the relevant persons appointed and authorised in the aforesaid manner shall be binding on us and you may, without any notice to us, debit any of our account(s) maintained with you (of whatever nature and whether matured or not) to effect or fulfil any liabilities pursuant to or otherwise in connection with the instructions and this authorisation letter.

We hereby authorise you and your officers, employees, agents (whether in Singapore or otherwise) and any other persons who by reason of their capacity or office have access to your records, registers or any correspondence or material with regard to our account(s) to disclose any information pertaining to us, our accounts maintained with you, our transaction(s), our instruction(s) effected or issued by us, to any party including but not limited to any appropriate authority, service provider, clearing house, counter-party bank, your head office, branches, subsidiaries or related companies and/or any third parties whom you consider appropriate to disclose, in Singapore or otherwise, as allowed or required by any law, regulation, judgment or order in any jurisdiction or as you think appropriate for any such purposes as you think fit. Further, we agree that the Bank's disclosure of information pertaining to our account/(s) with the Bank shall not constitute a breach of Section 47 of the Banking Act (Cap. 19) or any equivalent provisions or applicable laws in Singapore and we shall not hold you liable in any way for any loss or liability whatsoever and howsoever caused by or from any authorised persons or unauthorised persons who purportedly claimed to be authorised persons or misuse of information by the authorised persons.

This authorisation letter shall be governed by and construed in all respects in accordance with the laws of Singapore and we irrevocably and unconditionally submit to the non-exclusive jurisdiction of the courts of Singapore.
