The Customer is responsible for immediately notifying the Bank of any change in the e-mail address(es) authorized to receive the electronic statement or other relevant information. Customers that fail to receive the electronic statement due to changes in their e-mail address(es), unavailability of server, inefficiency or breakdown in telecommunications facilities or any cause other than the fault or gross negligence of the Bank, shall remain liable for any and all charges and/or penalties that may have been incurred or fallen due.

The Customer shall be solely responsible for the security and confidentiality of the electronic statements provided through e-mail. The Bank is not liable for the actions of the person(s) that have access to the e-mail address(es), or passwords of the Customer. In case of non-receipt, the Customer shall be responsible for informing the Bank immediately. Failure to receive the electronic statements will not excuse the Customer from liability for any and all charges and /or penalties incurred as result of improper or delayed acceptance.

The Bank may only disclose details of the Customer's account(s) to third parties pursuant to applicable laws and regulations or with the consent of the Customer.
